# **Diocese of Salford**

## Instrument of Government

#### ROMAN CATHOLIC HIGH SCHOOL

- 1. The name of the school is **St Patrick's Roman Catholic High School**.
- 2. The school was founded by and is part of the Catholic Church. The school is to be conducted as a Catholic School in accordance with Canon Law and the teachings of the **Roman** Catholic Church, and in accordance with the Trust Deed of the Diocese of Salford and in particular:
  - a) religious education is to be in accordance with the teachings, doctrines, discipline and general particular norms of the Catholic Church;
  - b) religious worship is to be in accordance with the rites, practices, discipline and liturgical norms of the Catholic Church; and at all times the school is to serve as a witness to the Catholic faith in Our Lord Jesus Christ.
- The school is a voluntary aided school.
- 4. The name of the governing body is "The Governing Board of St Patrick's Roman Catholic High School".

The governing body shall consist of:

- a. 2 parent governors
- b. 1 LA governor
- c. 1 staff governor
- d. 1 headteacher
- e. 7 foundation governors

Total number of governors = 12.

- 5. Foundation governors shall be appointed and may be removed by the Bishop of Salford (or any other person exercising jurisdiction on his behalf).
- 6. This variation to the instrument of government comes into effect on the day that it is made.
- 7. This Instrument of Government was approved by the Diocese of Salford on 5<sup>th</sup> October 2021 and made by order of Salford City Council on 1<sup>st</sup> February 2022
- 8. A copy of the instrument must be supplied to every member of the governor body (and the headteacher if not a governor), any trustees and to the appropriate religious body.

- 2 This is permissible under Provision 14 of The School Governance (Constitution) (England) Regulations 2012 and meets the minimum requirements for voluntary aided schools
- 3. The proposed constitution is 12 governors as follows.
  - 2 x parent governors
  - 1 x staff governor
  - 1 x headteacher
  - 1 x LA governor
  - 7 x foundation governors
- 4. To vary the IOG was agreed at the full governing board meeting held on 5<sup>th</sup> October 2021
- 5. The draft variation to the IOG has been approved by the Diocese and Governor Services and complies with the School Governance (Constitution) (England) Regulations 2012
- 6. The instrument of Government to come into effect on the date it is sealed
